PRESCHOOL POLICIES

- **APPROVAL PROCESS:** All applications are reviewed before a student is approved for enrollment. Enrollment Fee payments must be paid with applications before accepted.
- **ENROLLMENT FEE:** An Enrollment Fee is due with the application form and is non-refundable. Please refer to page 1 of the application for cost.
- **TUITION RATES:** Please refer to page 1 for the tuition rates based off the schedule you choose for your child.

K2 & K3 Preschool

Hours: 8:00am – 12:00pm daily – Days will depend on the chosen schedule.
Annual/Monthly Cost: Refer to page 1 of application.

- **EARLY WITHDRAWAL:** Please notify the Preschool Director at least 30 days prior to withdrawal of a child.
- **TUITION – MONTHLY:** Monthly payments are due the 1st of each month (August 1st – May 1st). All tuition payments are non-refundable.
GPEA operates solely on tuition fees and depends on all payments being paid promptly. Non-payment for preschool services and/or lack of adherence to tuition policies may result in dismissal of your child(ren) from the program. A late fee of \$25 is added to payments made after the 5th of each month. If tuition is not paid by the 15th of the month, your child could lose his/her spot.
- **PAYMENTS:** Make checks payable to “Grace Point Christian Academy”
Check payments may be mailed directly to 5934 Surret Drive, Archdale, NC 27263, or given in person in a labeled envelope. Cash and money orders must be paid in person and put in a labeled envelope.
- **RETURNED CHECKS:** There is a \$30 processing fee for all returned checks. No exceptions.
- **HOLIDAYS:** Tuition is calculated on an annual basis, based on the schedules listed on page 1. We do not pro-rate monthly tuition for holidays or absences due to illness, vacation, or inclement weather.
- **LATE PICK-POLICIES AND FEES:**
12pm Pick-Up Policy and Late Fee: We allow a 15-minute grace period. After 12:15pm, the parent will be charged \$15 and \$5 will be added every 5 minutes the parent/guardian is late after 12:15pm. This fee is due upon pick-up but, may be paid **no later than the following Monday** to avoid additional late payment fees. (** We understand if there are wrecks/natural disasters that may prohibit you from being on time. Please let the school know ASAP if you approach this inconvenience. **)
- **SCHOOL YEAR & HOURS:** Classes will start early September and run through mid-May. The first day of school for the 2025-26 school year is September 8, 2025.
Please refer to our GPEA annual calendar for any holiday information or school breaks. Grace Point Early Academy will adhere to all closings/delays that Grace Point Christian Academy posts. We will inform you of any closing or delays via ClassDojo and Facebook. Preschool doors will open at 7:30am (no earlier); school begins at 8:00am and ends at 12:00pm daily. You are required to walk your child into class daily, and you will also be required to pick up your child in class.

Grace Point Early Academy (GPEA) reserves the right, as circumstances may arise, to discharge a student from our preschool program. Parent/Guardian will be consulted before such action is taken.
